THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) No 1380/2013 of the European Parliament and Council of 11 December 2013 on the Common Fisheries Policy, amending Council Regulations (EC) No 1954/2003 and (EC) No 1224/2009 and repealing Council Regulations (EC) No 2371/2002 and (EC) No 639/2004 and Council Decision 2004/585/EC², and in particular Article 45 (3) thereof,

Having regard to Regulation (EU) No 1379/2013 of the European Parliament and of the Council of 11 December 2013 on the common organisation of the markets in fishery and aquaculture products, amending Council Regulations (EC) No 1184/2006 and (EC) No 1224/2009 and repealing Council Regulation (EC) No 104/2000³, and in particular Article 42 thereof,

Having regard to Regulation (EU) 2021/1139 of the European Parliament and of the Council of 7 July 2021 establishing the European Maritime, Fisheries and Aquaculture Fund and amending Regulation (EU) 2017/1004, and in particular Article 9 thereof,

Whereas:

- (1) The financing decision for the implementation of the 2022 and 2023 work programme of the European Maritime, Fisheries and Aquaculture Fund was adopted by Implementing Decision C(2022)371 of 26 January 2022.
- (2) Following a review of the actions adopted in 2022, a revision of the Annex to Decision C(2022)371 of 26 January 2022 has become necessary in order to update the work programme to the requirements for 2023. This includes deletions or updates in the pre-defined actions, additions of new actions or updates to the methods of implementation (or alternatively implementation modalities) in chapters *Grants*, *Procurement*, *Indirect Management* and *Other Actions and Expenditures* of the Annex to the work programme.
