Why common indicators?

- Show the main uses and achievements of the fund using common and comparable measures
- Any EMFF investment should contribute to one or more of these indicators
- Broad and general, not specific and detailed
- Continuity and simplification of current approach

How to use common result indicators

- Definitions in a Working Paper
- CPR Article 37: regular transmission of **result indicators, output indicators**, and financial information
- EMFF programme: select at least one common indicator per area of support
- Operation level in Infosys: provide the indicator-relevant information
- Automatic calculation of indicator values for CPR37 reporting, on submission of Infosys report

Infosys details to feed the indicators

- Beneficiary details and situation prior to investment (production volume, number FTE...)
- Sector (chose 1)
- Characteristics of investment:
- Type of operation (chose 1)
- Expected impact (*result indicator and value*)
- Series of tick-boxes: *Relevant to SSCF, LO, climate change, gender equality....*
- Beneficiary situation after investment - results

Main messages

- Common Result Indicators are broad and general
-headline uses and achievements of EMFF
- Definitions are detailed and inclusive
- More specific details are captured in Infosys
- No need for programme specific indicators
- To meet reporting obligations with least burden:
configure IT system to generate Infosys reports
on demand
